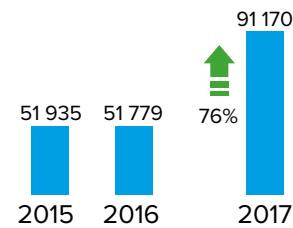

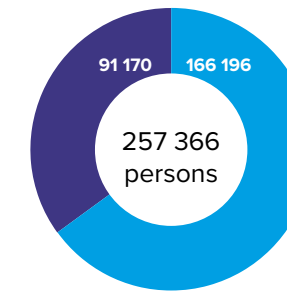

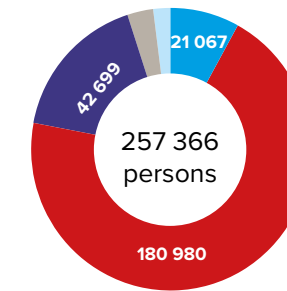

- 0,7% Private labs
- 0,1% Medical-scientific institute
- 2,6% Birth clinics
- 0,5% Other
- 0,6% Prevetion programme among key populations
- 0,3% Testing campaigns

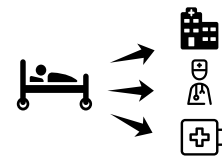

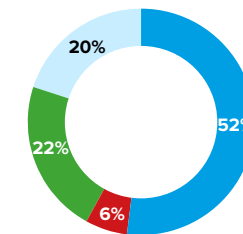

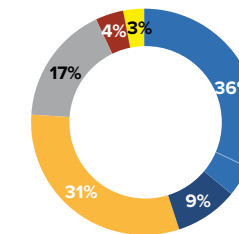
Budget of the Kyiv Fast Track programme 188 mln UAH (7 mln USD)

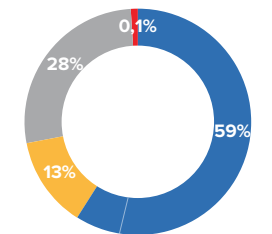
